## PATROL OPERATIONS DIVISION

Patrol Operations is comprised of 16 sworn officers under the leadership of a Major. Officers are assigned to one of four squads, each led by a Sergeant, working 12-hour shifts. Patrol Operations handles all dispatched calls for service, conducts self-initiated enforcement activities and provides high visibility patrols in hopes to prevent and deter criminal activity.

#### **STAR Corridor Update**

Officers handled **13** calls for service in this area; completed 76 park, walk and talk activities as well as **36** hours of traffic enforcement and general observation time. Officers had **163** community contacts.

#### **Patrol Highlights**

On April 1, officers were alerted to a possible DUI driver on Rt. 1. The vehicle was located and stopped on Slash Drive. The driver was arrested for DUI.

On April 1, officers were flagged down in regards to a hit and run in the 400 block of England Street. After an investigation, a suspect was located and arrested for DUI and hit and run.

On April 12, officers responded to Ashland woods for a brandishing weapon call. Completion of their investigation a male was arrested for brandishing, possession of Schedule I/II narcotics and possession of firearm with Schedule I/II narcotics.

On April 16, officers responded to a local business for a disorderly subject. That subject was arrested for obstruction and felony assault x2 on LEO.

On April 18, officers conducted a traffic stop, a brief vehicle then foot pursuit ensued. The male driver was apprehended and arrested on outstanding warrants, eluding/endangering, obstruction and registration violation.

On April 29, officers observed a suspicious vehicle in 100 block of W. Patrick Street. Four subjects in the vehicle were arrested for possession of marijuana.

Under the command of Special Operations Division, the **Investigative Unit** is comprised of three investigators led by Lt James Shelhorse. This operational component is responsible for the investigation of all felony and serious/repeat misdemeanor offenses reported to the police department. Additionally, this unit is tasked with proactive investigations into narcotics trafficking and other criminal behavior.
