PATROL OPERATIONS DIVISION

Major Anthony Callahan

Patrol Operations is comprised of 16 sworn officers under the leadership of a Major. Officers are assigned to one of four squads, each led by a Sergeant, working 12-hour shifts. Patrol Operations handles all dispatched calls for service, conducts self-initiated enforcement activities and provides high visibility patrols in hopes to prevent and deter criminal activity.

STAR Corridor Update

Officers handled **27** calls for service in this area; completed **49** park, walk and talk activities as well as **30** hours of traffic enforcement and general observation time. Officers had **82** community contacts and conducted **9** roll call meetings.

Patrol Highlights

On June 1, officers responded to Ashland Woods for a weapons violation. Upon completion of their investigation a male was arrested for brandishing a firearm.

On June 18, an officer was conducting a PWT (foot patrol) at Sheetz when the officer observed a male enter the business in a extremely intoxicated state. The male was arrested for Drunk in Public.

On June 25, officers received an abduction call in the 100 block of N. Carter Rd. After an investigation, the suspect was apprehended and arrested for abduction and brandishing a firearm.

On June 26, officers responded to a local business for a breaking and entering. After investigating, warrants were obtained for the subject, who was later located and taken into custody.

On June 28, officers were dispatched to the 200 block of S. Washington Hwy. for a disorderly call. The suspect was located and arrested on felony narcotics violations.

On June 28, officers located a wanted subject on two felony charges and arrested the subject on an additional felony charge. Units were assisted by Animal Control.

SPECIAL OPERATIONS DIVISION

Under the command of Special Operations Division, the **Investigative Unit** is comprised of three investigators led by Lt James Shelhorse. This operational component is responsible for the investigation of all felony and serious/repeat misdemeanor offenses reported to the police department. Additionally, this unit is tasked with proactive investigations into narcotics trafficking and other criminal behavior.

Investigative Highlights

Investigators downloaded three cell phones related to APD criminal cases.

Investigators conducted one pre-employment and one criminal polygraph exam for APD and another agency (12 hours).

Investigators spent multiple days dealing with a neighborhood dispute in which we assisted with the protective order process in court.

Investigators received two new CART complaint referrals from Social Services and one sex assault case which occurred years ago.

Investigators concluded an extensive investigation into a child abuse in which the suspect was sentenced to 18 months jail time. This was the result of a CART referral.

Investigators assisted with a search warrant by the HCSO in the 400 block of Chapman

Investigators conducted and attended semi-annual firearms training.

Investigator located a wanted subject who had an outstanding search warrant and felony warrant.

Investigators concluded a B&E investigation at the AT&T Store on Washington Hwy. Suspect was sentenced to 3 years in jail.

Under the command of the Special Operations Division, the **Crime Prevention/Logistics Unit** entails several functional components of the agency: Crime Prevention (1 officer), and the Auxiliary Unit (1 volunteer officers) and civilian volunteers all led by Sgt. Marie Kemp. In addition to duties tasked to individual members, this component is responsible for Recruitment, Selection, Training, Public Information, Special Event Coordination, and IT Administration.
